GIFT AID DECLARATION NOTES

1. As your declaration covers donations that you will make in the future, please notify us if you change your name or address while the declaration is in force.
2. You can cancel the declaration at any time by notifying us. It will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
3. Your declaration should not be based on the tax paid by another person (e.g. a husband or wife), but on you personally.
4. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that we can reclaim on your donations in the tax year.
5. If in the future your circumstances change and you no longer pay tax on your income or capital gains equal to the tax we reclaim, you can cancel your declaration as described in note 2.
6. If you pay tax at the higher rate, you can claim further tax relief in your self-assessment tax return.
